APPLICATION INSTRUCTIONS

CARPET TYPES

Su-Pro® carpet graphics must be applied indoors to clean low-pile commercial grade carpets that are in excellent condition. The carpet can be stain-resistant or non-stain resistant.

CARPET SURFACE

The carpet surface that is in excellent condition must be thoroughly vacuumed so surface is free of lint and debris prior to application of the graphics. If recently shampooed or steam cleaned, make sure that the carpet is completely dry before application of graphics.

CONDITIONS

The minimum carpet temperature is 55°F (13°C).

DECAL APPLICATION

Peel the backing paper or release liner 1" down from the top. Fold and crease the backing paper.

Align and apply the graphic, starting at the top and using firm strokes with a plastic squeegee (do not smooth decal with hands), stiff cardboard, or a soft cloth. Continue removing the backing paper and smooth out the squeegee. Re-squeegee the edges of the graphic using firm strokes to insure adhesion at the edges.

Remove the liner from the back of the decal. Position the decal on the desired location of the floor.

Using a plastic squeegee apply the center of the decal with firm pressure.

MAINTENANCE

Do not clean or vacuum over graphics for at least 48 hours after application.

If any edge of the carpet graphic decal lifts from the floor, the entire graphic must be removed immediately and replaced in order to prevent the risk of tripping.

Su-Pro® carpet graphic decals can be cleaned and maintained using routine carpet maintenance procedures and equipment.

Warm water or mild soapy dish detergent and a sponge can be used to periodically clean top surface of graphic.

REMOVAL

To remove the decal, lift one edge and pull at an angle using short, quick tugs. Pull at an angle of less than 45 degrees for best results.
